



Organic Acid Redistribution System

GENERAL INFORMATION

OARS is the corrective approach to manage the build-up of organic acids that coat the surface of sand particles which cause soil water repellency and localized dry spot conditions. When used as directed, **OARS** is safe to turf and can be applied at anytime of the year to avoid the detrimental impact of water repellency stress and localized dry spots on turf and to increase the vigorous appearance of turfgrass. **OARS** is easy to apply through standard spray application equipment to all turfgrass areas.

CAUTION

Not for use on Food Crops. KEEP OUT OF THE REACH OF CHILDREN. Read label before use. Wear goggles and chemical resistant gloves.

IN CASE OF CONTACT

In Eyes – Immediately wash eyes with large amounts of water for at least 15 minutes, lifting the lower and upper lids. Seek medical attention IMMEDIATELY.

On Skin – Remove contaminated clothing and immediately wash contaminated

area with large amounts of water for at least 15 minutes. Seek medical attention. If Swallowed – If person is conscious, immediately give large quantities of water. Do not induce vomiting. Do not induce vomiting or give fluids by mouth to an unconscious person. Seek medical attention immediately.

If Inhaled – Move person to fresh air and check to ensure adequate respiration. Seek medical attention immediately.

NOTE: If a pesticide is mixed with the OARS solution in the tank, follow the First Aid Directions on the label of the Pesticide.

Applicators and other handlers should wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove protective clothing and equipment after handling. Wash the outside of gloves before removing. Wash thoroughly and change into clean clothing.

DIRECTIONS FOR USE

Golf, Lawns, and Sports Turf

Apply 6 to 7 ounces in 2 US gallons of water per 1,000 $\rm ft^2$ (200 to 230 ml in 8 L per 100 $\rm m^2$) at 30 day intervals or as needed.

For increased penetration and surface firmness, apply 7 ounces in 2 US gallons of water per 1,000 $\rm ft^2$ (230 ml in 8 L per 100 $\rm m^2$) at 15 day intervals or as needed.

Irrigate after each application to remove the surfactant from the plant surfaces.

DO NOT combine **OARS** in the spray tank with pesticides or fertilizers unless prior use has shown the combination physically compatible, effective and non-injurious under local conditions.
