### DIRECTIONS FOR USE

Application recommendations based on soil fertility tests should be followed.

Apply **VERDE-CAL G** at 250 kg/ha (5 pounds per 1,000 ft<sup>2</sup> / 220 pounds per acre) at 30 day intervals throughout the growing season or as needed. If desired, **VERDE-CAL G** may be applied at 500 kg/ha (10 pounds per 1,000 ft<sup>2</sup> / 435 pounds per acre) once or twice per growing season or as needed.

After irrigating Greens and Tees using effluent water, apply **VERDE-CAL G** at 500 kg/ha (10 pounds per 1,000 ft<sup>2</sup> / 435 pounds per acre) at 30 day intervals throughout the growing season or as needed.

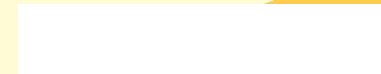
